Dear Secretary Mnuchin,

As you'll recall, I wrote to you on September 11, 2020, with my concerns regarding the Department of Justice and Internal Revenue Services' handling of coronavirus-related loan fraud. I am writing to you today to both follow-up on my requests and to raise concerns that President Trump may have received this funding by way of the more than 150 tenants that currently pay rent to the Trump Organization.

In my letter, I requested a response within ten business days regarding automatic forgiveness for financial recovery funds without verification of compliance with the terms and conditions established for program. I also requested justification for such forgiveness and why it is acceptable for the American taxpayer to be defrauded of billions of dollars. I am still very interested in responses to these questions and am disappointed that I have not heard word from your office, including acknowledgement of my letter.

Additionally, considering the recent report by the *New York Times* (NYT) on September 27, 2020, which details President Trump's tax records, I believe it is especially important that your office make available any and all instances where the President's businesses or tenants received any form of a PPP or an Economic Injury Disaster Loan (EIDL). This includes any company that President Trump has significant financial interests, such as Vornado Realty Trust and its tenants.

It has already been widely reported that multiple businesses with ties to the President received millions of dollars in small business loans. ² For instance, as much as \$273 million in federal coronavirus aid was awarded to more than 100 companies that are owned or operated by major donors to the President's election efforts.³ The NYT report now raises new questions of whether any of the 500 businesses under the Trump Organization also benefited from federal relief programs. Also, if one of the more than 150 tenants of the Trump Organization received a PPP grant or EIDL, then the President would be greatly benefiting from the funds in the form of rent payments as the landlord. This is very concerning.

Congress voted and passed relief programs as part of the CARES Act to help struggling businesses and families weather the storm and get through this unprecedented global health pandemic. To have that much-needed aid be abused and misused is unacceptable. To have that aid potentially awarded to some or potentially all of the President's businesses or tenants at the expense of struggling small business owners is troubling. The Treasury Department must make every effort to ensure the resources Congress allocated reach those for whom they were intended. The American people have the right to know whether these extraordinary measures were administered fairly or if they personally benefited the President of the United States.
